

# End User License Agreement

Effective: June 5, 2026 designflare.de

This End User License Agreement ("EULA") is a legal agreement between you ("Licensee", "you") and DesignFlare, operated by Ayoub Esadik ("Licensor", "we", "us"), for the use of coded website templates, UI components, source files, and related digital assets ("Licensed Materials") purchased from <https://designflare.de>.

## 1. Acceptance

By downloading, accessing, installing, or using any Licensed Materials, you agree to be bound by this EULA. If you do not agree, do not download or use the Licensed Materials and contact us for a refund in accordance with our Return Policy.

## 2. License Grant

Upon full payment, we grant you a limited, non-exclusive, non-transferable, revocable license to use the Licensed Materials subject to the terms of your purchased package:

- **Personal / Single Project:** Use in one (1) end product or client project
- **Commercial:** Use in multiple client projects and commercial deployments as specified in your package tier
